We customarily charge our time in quarter hour increments for billing efficiency.

We bill on a monthly basis and it is our policy to require payment of invoices within thirty (30) days of the date of the invoice. Thereafter, an interest charge of 1 1/2% per month will be assessed against invoices which are outstanding for more than forty-five (45) days. Normally, a retainer is required for all cases at the time of our retention. This retainer must be kept intact (held in escrow) and not used to offset our billings until our representation is concluded. The retainer will be waived for the West Goshen Sewer Authority.
