The following summarizes recent activities performed on behalf of the West Goshen Sewer Authority (WGSA) for developer activities within the sanitary sewer service area:

Jerrehian Estate-Large Tract-Woodlands at Greystone-#126

Start-up activities for Pump Station A and Pump Station B were successfully completed. We are waiting on final record drawings and start-up reports from the Contractor/Developer for both stations.

The Developer has requested a drawdown of the financial security for the sewer improvements. HRG has reviewed the pump station work and forwarded the remaining items to Carroll Engineering for their review and recommendation, as they completed the on-site inspection and witnessed all of the final testing. No response has been provided since the request made on November 14, 2019.

825 Goshen Road-#205

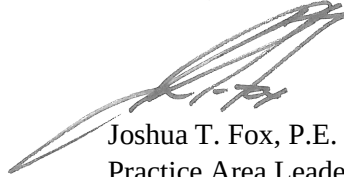
