Mr. Pielli opened the meeting at 7:02 p.m.

On a motion by Mr. Sheller, seconded by Mr. Stratton, the Task Force approved the November 28, 2017 meeting minutes.

Mr. Ott stated that the Community survey revisions are the same from the last meeting. Ms. Sarcinello stated that the "Community Survey" notice on last page of survey stated to check Township website for upcoming Comp Plan Public Workshop date.

Ms. Sarcinello stated that multiple family members will be permitted to fill out separate surveys. We need to determine a date to return the survey by to ensure the results may be tabulated.

Ms. Sarincello stated that for Question 1, new items were listed.

She stated that for Question 2, two different scope of questions.

She stated that several other open-ended questions were added, plus some optional demographic questions were added.

A brief discussion ensued regarding inclusion of the two Question 2 alternatives. One alternative was slightly longer, while the second alternative was shorter with a ranking component.

Ms. Richter suggested indicating from the list in Question 2, what are your five (5) most important issues from the list with an added Question 3. The Task Force endorsed Ms. Richter's suggested format.

The Task Force agreed to set March 27th for the Public Workshop. Mr. LaLonde and Township staff will get the community survey out by February 2nd to homes and on the website with a deadline of March 2, 2018. A Survey Monkey version of the survey will be posted on the Township website as soon as possible.

Ms. Sarcinello reviewed the Issue Identification Questionnaire for the Task Force members.

Ms. Sarcinello requested the Questionnaire be submitted to Mr. Davis by February 13th so he may get the results to Mr. Ott and Nanci.

Mr. Ott introduced the idea to identify and name commercial and residential areas. He stated that many neighborhoods in the Township are already named neighborhoods. He would like the Task Force to name any additional new neighborhoods. The Task Force provided names for various historical neighborhoods in the Township.

Ms. Drowniany suggested we term the Public Workshop "Interactive" to ensure the public knows they will be participating in the workshop. Mr. Ott agreed to add the word interactive to the workshop list.

There being no additional business, on a motion by Mr. Sheller, seconded by Ms. Drowniany, the meeting was adjourned at 8:23 p.m.

The next Task Force meeting is scheduled for 7:00 p.m., Tuesday, February 27, 2018.
