New Park Planned for 2005

West Goshen will have a new park in the northern part of the Township by late 2005.

Even though the park is over a year away from opening, it is safe to say this park is going to the dogs. Or, to be more specific, a portion of the park will be dedicated to dogs and dog lovers.

The new 3.5 acre park will also provide inline skaters and skateboarders with a place to practice their skills and include two tennis courts to meet current demands for facilities to practice and play on.


The new park will be located along Pottstown Pike, just south of the recently renovated Wawa at Pottstown Pike and Greenhill Road. Land for the park was donated to West Goshen Township by Wawa.

The park will serve various needs of residents and neighbors of West Goshen Township.



An area of the park will be fenced in providing a safe area where dogs may exercise unleashed. This area will allow dogs and their human partners to play catch, practice obedience training, or just run without endangering other visitors to the park. A portion of the fenced-in area will also have an agility course for dogs, with obstacles and

other canine-friendly equipment. Special water fountains will be installed so humans and their companions will both be able to cool down with a drink of water. As with many of West Goshen's parks, dog bags will be available so owners can clean up after their pets.



Despite the growing popularity of skateboarding and inline skating, appropriate, safe facilities are usually not readily available. Tennis court and basketball court surfaces are incompatible with skateboard usage. Often, skateboarders turn to dangerous or unauthorized places such as sidewalks, staircases, or homemade courses designed with picnic tables and trashcans, to hone their talents. The nearest public (not for-profit) skatepark to West Goshen Township is nearly twenty miles away in Kennett Square.

The Pottstown Pike park will have a 110 foot by 220 foot skatepark providing ramps and obstacles for participants of all skill levels. A viewing gallery will allow parents, friends, and others to comfortably watch skaters and boarders without fear of being endangered by errant skateboards. The Township will require helmet and knee and elbow pads before anyone is permitted to enter the skatepark. West Goshen Township currently has



four tennis courts, all located at Community Park at Fern Hill and N. Five Points Roads.

United States Tennis Association teams schedule court usage for games. Individuals and groups utilize the courts for practice. The West Goshen Summer Recreation Program organizes tennis clinics for children nine through twelve years old. And, of course, the tennis courts are a popular site for countless pick-up games.

Two additional courts at the new park will provide an alternative for the casual or serious tennis players looking for a place to play.



This park will be West Goshen's first in the northwest part of the Township, helping to bring convenient recreation opportunities to residents in that area. The new park will also provide many of the amenities people have come to expect from West Goshen's parks. Water fountains, bathroom facilities, picnic tables and other places to sit and rest will be available.

Building Codes Adopted

West Goshen Township recently adopted the International Codes 2003 edition published by the International Code Council amending the code of West Goshen Township. The International Code Council, an association committed to building safety and fire prevention, develops the codes used to construct residential and commercial buildings, including homes and schools. The International Codes adopted by the Township include the 2003 International Building Code, International Existing Building Code, International Residential Code, International Electrical Code, International Mechanical Code, International Plumbing Code, International Fuel Gas Code, International Energy Conservation Code, International Fire Code and International Property Maintenance Code. The purpose of these codes is to establish minimum requirements through regulations that safeguard the public health and safety. Legal Briefs

■ Motorized scooters are not permitted on sidewalks or roads and are only permitted on private property with the owner's previous consent and approval.

■ The following weeds may not exceed 12 inches on any land in West Goshen Township: ragweed; chicory or blue daisy; Canadian thistle; multiflora rose; Johnson grass; any other species of noxious weeds. In addition, grass, brush, and similar vegetation may not exceed 12 inches.

■ Tree limbs, hedges, or other plant growth may not hang into the road and must be cut back of the curb line.

Do Your Part To Keep Our Water Clean

All of West Goshen's storm drains empty either directly into the nearest stream or into a local drain basin with any overflow going to local streams. Pollution from used motor oil, antifreeze, or lawn and garden chemicals and other materials that enter the storm drain system quickly contaminate the local streams and groundwater. There are no treatment facilities to remove contaminants that enter the storm drain system.

There is growing national concern about the effects of stormwater contamination on the natural environment. The Environmental Protection Agency (EPA) estimates

that over 60% of our water pollution comes from urban and agricultural storm water runoff. The EPA and the Pennsylvania Department of Environmental Protection (DEP) prohibit discharging any contaminants into the stormwater system. Violators are subject to fines as required by law.

You can help reduce the pollution of local streams and groundwater by using lawn and garden products carefully according to their directions and returning used automotive fluids and toxic household waste to the recycling centers listed below:


■ **Free Activities for Children:** Children can have fun all afternoon without emptying their parents' wallets or pocketbooks. Free activities for kids include:


Walk With Us

Construction Begun at Paoli Pike and N. Five Points Road

The Pennsylvania Department of Transportation (PENNDOT) has begun construction on traffic improvements at the intersection of Paoli Pike and N. Five Points Road. The roadwork is expected to last through the summer.

Traffic may become congested during construction. Please allow extra time if you need to use this intersection. Alternatives include West Chester Pike or the Route 322 exit of Route 202. Remember that state law requires drivers to use headlights when driving through a construction area. Fines for traffic offenses are doubled in construction zones. ★

Keep Your Cool & Save Some Cash

PECO Energy offers the following top 10 energy savings tips to keep your energy bills down and your home cool:

 Keep your thermostat at a constant, comfortable level of 75-78 degrees when you are home. Lowering the thermostat setting will not cool your home any faster.

 To reduce heat and moisture in your home, run appliances such as ovens, washing machines, dryers, and dishwashers in the early morning or evening hours when it is generally cooler outside. You can also reduce the kitchen heat by microwaving or barbecuing outside instead of using your stove or oven.

 Keep shades, blinds, and curtains closed. Nearly 40% of unwanted heat enters building through windows.

 Don't place lamps or televisions near your air conditioning thermostat. The heat from these appliances will cause the air conditioner to run longer.

 Turn off all unnecessary lighting and appliances.

 Use fans to circulate cooled air. This will more evenly distribute cool air and can reduce the amount of time your air conditioner is turned on.

 Place window air conditioners on the north or shady side of the apartment or house when possible to avoid overworking the unit in the hot daytime sun.

 Replace the air conditioner filter at the start of the cooling season and check its condition monthly.

 Install or replace caulking or weather stripping around doors and windows to keep cool air inside.

 If shopping for appliances such as refrigerators, freezers, and air conditioners, look for the Energy Star label and purchase the most energy efficient unit you can afford. These newer, more energy-efficient models will lower monthly operating costs.

By taking these simple energy efficient steps, you can save up to 10% to 15% of your energy costs. ★

Lawn Mowing Tips

According to the American Academy of Pediatrics, nearly 68,000 people are treated in emergency rooms each year with lawn mower related injuries. When mowing your lawn, make sure to take the following precautions:

- Use a lawn mower with a release that automatically stops the engine when you let go of the handle. Riding mowers should have a release that turns the engine off when you get up from the seat.

- Wear sturdy shoes (not sandals or sneakers) when mowing your lawn. Protective eyewear, hearing protection, workgloves, long sleeved shirts, and full-length pants are also recommended.

- Walk across your yard removing objects from your lawn before mowing. Items left on the lawn may become dangerous projectiles if run over by a lawn mower.

- Keep children and pets away from lawn mowers. Do not allow children to ride as passengers on riding mowers. Children under 16 should not operate riding mowers. Children under 12 should not use walk-behind mowers.

- Always turn off the mower and wait for the blades to stop completely before removing the grass catcher, unclogging the discharge chute, or crossing gravel paths or roads.

- Start and refuel mowers outdoors, not in a garage or shed. Only refuel mowers when the engine is turned off and cool.

- If mowing a steep incline with a riding mower, go straight up and down to avoid tipping over. If using a walk-behind mower, move horizontally across the slope to avoid being run over by the mower. ★

Safety Tips from Officer Friendly

Keep your children safe when they get on their bicycles.

- Children should avoid riding bicycles in the street whenever possible. If possible, they should stick to riding bikes on sidewalks or driveways. If children must ride on a street, make sure to ride on the right side of the street.

- Bicyclists must adhere to the same traffic codes as automobiles. This means that bicycle riders must stop at red lights and stop signs.

- And of course, bicyclists must wear helmets at all times. ★

Know the Rules Before Installing Your Pool

Make sure your pool is safe this summer.

West Goshen's building codes require a fence or other barrier of a height of at least 4 feet around any pool. Any gates leading to the pool area must have a self-closing latch at least 54 inches above the ground.


Houses with doors leading to pool areas must be equipped with an alarm that sounds for 30 seconds when such doors are opened. The alarm may have a deactivation switch located at least 54 inches above the threshold of the door that resets itself within 15 seconds. The purpose of the alarm is to prevent accidental drownings by notifying homeowners when any children leave the house for the pool area.

Above ground pools must have ladders that can be removed, locked, or secured to prevent access when the

pool is not in use. Remember that above ground pools are subject to the same regulations as in-ground pools. Before purchasing an above ground pool two feet deep or deeper, don't forget to budget for proper enclosure and alarm if needed.

Other ways to keep your pool safe include keeping rescue equipment near the pool, making sure children do not enter the pool unattended, and maintaining a distance of no more than one arm's length away from any infants or toddlers in the swimming pool.

DON'T GET BUGGED THIS SUMMER

Insects can be more than a nuisance during the summertime. With growing awareness of Lyme disease and West Nile virus, the serious health risks presented by some insects need to be addressed. Fortunately, there are some fairly simple precautions you can take to make yourself less likely to get bugged this summer.



Don't make yourself too attractive to insects. Avoid using scented soaps, perfumes, or sprays when heading into wooded areas. Some insects are also attracted to bright colors and flowery prints.

The best protection is prevention. Avoid areas where insects nest or congregate, such as stagnant pools of


water, uncovered foods and gardens where flowers are in bloom. Wear long sleeved shirts and a hat and tuck pant legs into your socks when heading into the woods. Avoid wearing sandals or other open-toe shoes. Protect any exposed skin with an insect repellent containing DEET.



Consider building a bat box in your back yard. A single bat can eat up to 3,000 mosquitoes per night.



When stung by a bee or wasp, remove the stinger by gently scraping it off horizontally with a credit card or your fingernail. Do not use a needle to remove the stinger unless it has been sterilized first. ★



Summer Fire Safety Tips from Fire Marshal Ralph Brown

West Goshen Township prohibits the manufacturing, sale, exposure for sale, or use any fireworks, firecrackers, torpedoes, roman candles, skyrockets, sparklers, and all other articles of the nature or character of fireworks for pyrotechnic display. Of these items, only sparklers may be legally used in the state of Pennsylvania.

When using sparklers, maintain a safe distance from buildings, trees and bushes, and vehicles. Children under 18 must be supervised by an adult when using sparklers. Young children are advised not to play with sparklers. Allow sparklers to cool down before touching or depositing in your trash.

Do not include any unlit fireworks with your trash. Instead, contact Fire Marshal Ralph Brown at 610-696-5266 to safely dispose of them. ★
