## Learn How Deer Overpopulation Affects You

The West Chester Area Council of Governments (WCACOG) will host a deer management public education forum on Wednesday, November 16, 2005 at 7:00 PM in the Henderson High School

Auditorium. The goal of this session is for experts in deer management to share practical insights into the very serious issue of deer overpopulation and its attendant problems with residents.

### **Speakers Include:**

■ The Honorable State Representative Chris Ross of Pennsylvania's 158th District will be the introductory speaker, and will address deer overpopulation in the state and in our region, and measures the State Legislature has taken to address the problem.

### Bulk Trash Now Collected Every Thursday

Large bulk items will now be collected every Thursday. Prior to this time, bulk pickup had been limited to the first Thursday of each month. Households will still be limited to one bulk item per pickup. Remember that refrigerators, freezers, or air conditioners must have a sticker indicating that the freon has already been removed before these items may be left for pickup. - Keith Mullin, Wildlife Conservation Officer for the Pennsylvania Game Commission, will provide an update on efforts to reduce the deer population and discuss hunting laws.
- Tim Smail, wildlife conservation biologist and representative of the nationwide Quality Deer Management Association, will focus on the relationships between hunters and property owners.
- Dr. Richard Lighty, former Director of Research at Longwood Gardens, will offer advice on the selection and protection of home landscaping.
- Wiliam R. Hewton, a former Kennet Township Supervisor and member of that township's Deer Management Committee, will speak about the municipal perspective and role of local government in deer management.
- The Lyme Disease Association of Southeastern Pennsylvania will also participate in this session, with tips on disease prevention, recognition, and medical treatment.

### **Recent Zoning Changes**

On July 27, 2005, the West Goshen Board of Supervisors adopted an ordinance which would create a new R-3.A single family attached dwelling overlay district which permits single family attached dwellings on certain parcels of property in the existing R-3 zoning district subject to specific area and bulk requirements and design standards.

On August 10, 2005, a consolidated ordinance was passed to allow outdoor dining as an accessory use to a stand alone restaurant in the C-2, C-4 and C-5 zoning districts; noncommercial athletic courts as an accessory use to a single family dwelling in the residential zoning districts subject to specific criteria; to add the definition for "Convenience Store" and to permit such a use in the C-I zoning district by conditional use approval from the Board of Supervisors; to add the definition for "Pharmacy/Drug Store" and to permit such use in the C-I and C-2 zoning districts by conditional use approval; to add specific regulations for a Convenience Store and Pharmacy/Drug Store; and to amend the use regulations for the C-5 district to remove automobile body repair and automobile repair shops as permitted uses and to allow such uses in the I-2 districts.

On September 14, 2005, the West Goshen Board of Supervisors approved an amendment to the revised West Goshen Zoning Ordinance of 1990, specifically the West Goshen Township Zoning Map, by rezoning two adjoining parcels previously zoned C-2 and C-1R respectively to C-1 zoning. The two parcels are located at the intersection of Phoenixville Pike and Boot Road.

All meetings are held in the Township Administration building except the Sewer Authority, which is conducted at the Sewer Treatment Plant at 848 South Concord Road. There is a public comment period at each meeting. Additional Zoning Hearing Board Meetings may be added as needed. West Goshen Township publishes approved minutes, agendae, and updates and changes to public meeting on the Township's website, www.westgoshen.org.

As a service to the residents and businesses of West Goshen Township, the West Goshen Township Newsletter includes a Trash and Recycling Guide in the spring and fall issues.

Leaf Pick-up: Leaves will be picked up on the following Saturdays: November 5th, November 19th, and December 10th. Leaves can be placed in biodegradable bags or trash cans. If using plastic bags, provide a container in which plastic may be left so they could be used again. There is no limit to the number of bags.

## **Christmas Tree Disposal**

Christmas trees will be accepted to be mulched at the West Goshen
Municipal Complex from January
3 through January 18, 2006. Remove all tinsel, decorations, and plastic bags from trees. Wreaths will not be accepted.

Remember—mulching your tree saves valuable landfill space and takes advantage of a natural, renewable resource.

### Residential Trash Pickup in West Goshen Township

his waste and recycling guide contains information about West Goshen Township's residential trash and recycling pickup. Residential establishments with four or more units and commercial, municipal, and institutional establishments shall contract at their sole cost and expense for the collection of waste and recyclables. Such establishments may select any collector/hauler licensed by West Goshen Township. Information about recycling can be found on the following page.

**Bulk Trash:** Beginning in October 2005, bulk trash will be picked up each Thursday. A bulk item is an item which two people can lift. Refrigerators, air conditioners, and other freon containing items must be tagged that freon has been removed. No building materials, railroad ties, automotive parts, or tires will be picked up. If unsure whether or not your bulk trash item will be collected, call the trash hauler, BFI, at 610-869-2222.

**Household hazardous waste** items listed below may not be disposed of with household garbage, but may be brought to hazardous waste disposal sites which will be listed in the Spring 2006 Township Newsletter. Commercial and industrial entities are excluded from this program.

## Your Guide to Recycling in West Goshen Township

## WHO MUST RECYCLE?

- Students/staff of both public and private primary, secondary, and post-secondary schools
- Residents of hospitals, dormitories, and nursing homes
- Employees of institutions, public agencies, commercial entities, and industry
- Owners of restaurants, shopping centers, stores, office buildings, and factories
- Persons living in single family homes, condominiums, townhouses, or apartments

# WHO MUST HAVE A RECYCLE PROGRAM?

- Commercial Properties: stores, markets, office buildings, restaurants, and shopping centers
- Industrial Properties: factories, foundries, processing plants, and warehouses
- Institutions: hospitals, nursing homes, private and public schools and universities
- Public agencies: government agencies, authorities and councils
- Multi-unit residences: apartment buildings with four or more units and condominium associations

Each owner, operator, or administrator of one of the above mentioned categories is required to provide to each occupant, employee, patron, or resident written material describing its recycling program. Written instructions should clearly describe what materials are to be recycled, how the materials are to be prepared, and how the collection system works. The owner, operator, or administrator must provide for collection of the recyclable materials at least once per month.

The recycling containers must be easily accessible and suitable for the type of material that is being collected. Educational facilities should provide for separation and collection of recyclable materials in classrooms, administrative offices, cafeterias, and dormitories.

# WHAT MATERIALS MUST BE RECYCLED?

Commercial, municipal, and institutional establishments must provide, at a minimum, for the separation and recycling of the following materials:

- Computer paper and white bond/copier/letterhead paper
- Corrugated paper
- Aluminum, steel, and bimetallic cans

**Multi-unit Residences** (apartment buildings and condominiums) must provide for the separation of and recycling of at least three of the following materials:

- Clear and colored glass
- Aluminum, steel, and bimetallic cans
- #1 and #2 plastics
- Mixed paper including newspaper, junk mail, telephone books, catalogs, white paper, magazines, flattened boxes which do not come in direct contact with food, and non-corrugated cardboard

Check with your apartment complex or condominium association to determine which materials to recycle.

## Single Unit Residences must recycle, at a minimum:

- Green, brown, and clear glass
- Aluminum, steel, and bimetallic cans
- #1 and #2 plastics
- Mixed paper including newspaper, junk mail, telephone books, catalogs, white paper, magazines, and flattened boxes which do not come in direct contact with food

Paper products must be tied or bundled in paper bags.
Corrugated cardboard (optional for recycling) must be bundled into one foot by one foot units. All other items must be placed in a West Goshen Township plastic recycle bucket or a trash can with a Township recycle sticker attached to it. Recycle stickers are free and may be obtained from the Township. If you have moved into a new construction, you may obtain a recycle bucket at no cost at the Township Administration Building. Twenty gallon recy-

cling buckets may also be purchased for \$7 each from the Township. Mark each bucket with your street and house number. Place at curbside before 6:00 AM or the night before. Residential recycling is collected on Mondays, or the following Tuesday if Monday is a holiday.

### Safety Tips from Officer Friendly

id you know that West Goshen Township has a curfew? Chapter 34 of the West Goshen Township Code establishes that it is unlawful for anyone under 18 years old to remain on any streets or in public places or establishments between the hours of 10:00 PM and 5:00 AM.

The curfew law does allow for the following exceptions:

- The curfew does not apply to anyone under 18 accompanied by a parent or legal guardian 21 years old or older.
- Anyone under 18 whose work requires him or her to exceed the curfew hours may do so provided that person carries identification and evidence in writing of work requirements.
- Between June 15 and September 15, the hours of curfew on Friday and Saturday evenings are 11:00 PM through 5:00 AM.

Minors who violate curfew, parents who allow minors to violate curfew, and operators of establishments who knowingly permit minors under the age of 18 to remain on their premises during curfew hours may be prosecuted and face fines of \$100 to \$1,000 per day of violation plus court costs. ★

### Fire Marshal Report: Burning Yard Waste

West Goshen Township allows for the burning of twigs and tree limbs in an enclosed container, incinerator, fire-place, or grill between the hours of 10:00 AM and 4:00 PM. Burnings for the purpose of cooking food for human consumption are exempt from these hours.

Burnings are restricted to twigs and tree limbs. It is unlawful to burn other materials, including (but not limited to) leaves, brush, lumber, building materials, and construction waste materials.

Burnings confined in enclosed containers must take place at least 10 feet from any building or structure, unless the building or structure contains a fireplace, incinerator, or grill meeting the requirements of the West Goshen Township Building Code. Burnings



may not be left unattended.

Open fires not enclosed in a container are only permitted when the closest point of the fire is at least 20 feet from a building, structure, trees, shrubs, and other combustible materials, wind speeds are less than 15 miles per hour, and an accessible water source and sufficient hose length is available to reach the core of the burn area. Open fires may not be left unattended.

Yard waste burnings may be restricted or banned by the West Goshen Board of Supervisors if they pose a serious threat due to drought or other hazardous conditions.

Any fire on public or private property may be extinguished by the local fire company with or without consent of the property owner if the fire is deemed dangerous by the West Goshen Township Fire Marshal, a West Goshen Township Police Officer, or a Township Codes Enforcement Officer.

Fire Marshal Reports are presented by West Goshen Township Fire Marshal Andrea Testa. \*

### How to Dispose of Household Health Care Waste

The Chester County Health Department recommends the following steps be taken when disposing of items that have come in contact with blood.

Place all needles, lancets, syringes, and other sharp objects in a puncture-resistant, hard plastic or metal container. An empty detergent bottle with a screw-on cap or an empty coffee can will do.

Close the container with its original lid and secure with heavy-duty tape.

Place the tightly sealed container in a paper bag and discard it with your household trash.

Place non-sharp home health care wastes in a doubled securely fastened opaque plastic trash bag before putting them in your garbage can with other wastes.

Needles, lancets, syringes, and other sharp objects should be disinfected with a solution of I teaspoon of bleach in I/2 gallon of water prior to disposal. Household health care wastes should not be placed with recyclables. Some pharmacies may sell specially designed containers for homeowners to use to dispose of household health care waste. \*

Helen Heidelbaugh, President and CEO of Community Volunteers in Medicine (CVIM) emphasizes the importance of health care for Chester County's working poor.

The County has
45,000 residents who earn a gross income of 200% of the federal poverty level or less and are not eligible for Medical Assistance, Medicare, Veteran's Benefits, or the Children's Health Insurance Program. For these families, Community Volunteers in Medicine offers the only affordable way to visit dentists and physicians or to acquire desperately needed prescriptions.

CVIM has been serving Chester County residents since 1997. In August 2001, the nonprofit organization moved to its current home on Lawrence Drive near West Goshen Community Park.

More than 185 volunteers, including physicians, dentists, dental hygienists,

registered nurses, nurse practitioners, social workers, and administrative workers offer their services to CVIM. In addition, students from local medical and dental schools gain practical experience at CVIM while providing vital services to County residents in need. CVIM has also established a network of doctors offering services for patients needing surgery or specialty care not available at the CVIM offices.

All of CVIM's clients must be currently employed, earn less than twice the federal poverty level, and not have any health insurance coverage. According to Heidelbaugh, "Their paystub counts as their insurance card." Patients pay whatever voluntary contributions they can. Last year, patient contributions totaled \$45,500 towards CVIM's 1.4 million dollar budget.

Overall, 62% of funding comes from individuals, 21% comes from foundations, 13% comes from corporations, and 4% comes from other sources.

CVIM strives to fill a gap in health care by providing services not offered by government agencies or other non-profits. In 2004, these services included more than 5,000 dental visits and an equal number of primary medical care visits and the dispensation of more than 25,000 prescriptions. For people needing medical, legal, or other

assistance not provided by CVIM, Community Volunteers in Medicine provides a referral to other service providers. Patients are often referred to CVIM through homeless centers or other social

service providers, schools, churches, or the County Departments of Health and Welfare.

Helen Heidelbaugh points out the CVIM can always use the assistance of doctors, dentists, and other health care workers or retired professionals wanting to volunteer their time. Volunteers fluent in Spanish are especially needed. She encourages West Goshen residents to visit www.cvim.org or visit their offices at 300-B Lawrence Drive (between Mauger Oil and Moonbounce Adventures) to learn more about how to make a contribution or volunteer time towards the mission of "Providing healthcare, hope, and healing."

### Fran Halvorsen Remembered

Longtime West Goshen Township employee Frances Perry Halvorsen died after a long illness on August 25, 2005.
