Call Before You Dig

With underground gas, electric, water, and communications lines crisscrossing West Goshen Township, any excavation can lead to a close encounter with dangerous, even life-threatening hazards.

To avoid these dangers, call 8-1-1 prior to undertaking any digging including tree planting, deck building, or mailbox post installation. Much like other existing "Call Before You Dig" services, calls will continue to be routed to the

respective one-call centers who will notify the affected utilities who will then mark the underground lines for free. 8-1-1 provides one easy number to be used nationally to access this service.

8-1-1 is administered by the Common Ground Alliance, an organization consisting of over 1,400 partners including government agencies and regulators and companies in the fields of excavation, road building, electricity supply, telecommunications, oil, gas, railroad, equipment manufacturing and supplies, insurance, engineering and design, and one-call centers. KNOW YOUR WATERSHEDS AND STREAMS

Streams are an important part of life in West Goshen Township. Although they do not play the same role as they did in colonial times when they were frequently dammed to supply water power for mills, they are still very important ecologically and in defining the character of your community.

Do you know where West Goshen's streams come from or where they are going? West Goshen has two major drainage systems, both of which ultimately drain to the Delaware River, the Chester Creek drainage system, and the Brandywine/Christina River drainage system.

West Goshen Community Park Fern Hill & North Five Points Roads The easternmost portion of the township is drained by the East Branch of Chester Creek, which begins near Route 202 at the West Whiteland border and forms the West Chester Reservoir on Fern Hill Road, operated by Aqua Pennsylvania, before flowing into East Goshen Township. Goose Creek begins under the parking lot behind the West Goshen Shopping Center. It drains the area east and southeast of the Borough, before flowing through Westtown and joining up with the East Branch of Chester Creek near Route 926 in Thornbury. Both the East Branch and the Goose Creek are "flashy" streams, meaning that they overflow their banks easily and are continuing to erode significantly because of the significant amount of urbanized and paved headwaters of these sub-watersheds (exceeding 50% and 75% impervious cover) and historic floodplain encroachment. Two major wastewater treatment plants also discharge to Goose Creek in West Goshen (West Goshen's and West Chester Borough's).

The section of the Township north of West Chester Borough is drained by Taylor Run, and the small portion of the Township south of West Chester Borough and to the west of Route 202 is part of the Plum Run watershed. Both Taylor Run and Plum Run are part of the Brandywine. These streams are also negatively impacted by pollutants carried by stormwater and increased peak runoff due to modification of the area's natural hydrology.

West Goshen Township is working with the Chester Ridley Crum Watersheds Association and Brandywine Valley Association to protect your local streams.

The following plans have been approved for development:

- Henderson Athletic Fields & Parking – A lot consolidation to provide for athletic fields (soccer field with natural turf, soccer field with synthetic turf, and tennis courts), parking facilities, and a fieldhouse with restrooms for West Chester Area School District located at 101,401, 501, 505 Montgomery Avenue and 790 Lincoln Avenue.
- CMC Ten-O-Three A four lot consolidation to construct a 5,886 square foot retail/warehouse addition on property located at 1003 West Chester Pike. The addition will consist of an expansion for the existing MAB Paint store, as well as additional space for flex/office use.
- ANRO, Inc. A 9,000 square foot addition to an existing building located in the I-2 Zoning District, formerly occupied by Electronics Boutique. The applicant, ANRO, Inc., proposes to conduct a printing business from the site.
- 825 Goshen Road Subdivision The subdivision of a 3.5 acre lot into five single family residential lots. The site is within the R-3 Residential Zoning district, and will be served by public water and sewer facilities.
- The Jefferson at Matlack A land development depicting a 68,034 square foot luxury apartment complex with a 24,500 square foot parking garage located at the northwest corner of the intersection of the West Chester Bypass (S.R. 202) and Matlack Street. The land development will also include road improvements to the intersection of West Chester Bypass (S.R. 202) and Matlack Street. The property is located at 890 South Matlack Street and is currently occupied by Spaz Beverage.
- Keystone Community Alliance A Land Development Plan for two 5,000 square foot office buildings, located at 831 Lincoln Avenue (Lincoln Independence Park).

The following plans are currently in the review process:

• Liberty Tool – This land development proposes a 26,000 square foot ware-

house building for Saunders Lane, LP, located at 1005 Saunders Lane.

• Citadel Federal Credit Union – The proposed plan depicts a 19, 905 square foot credit union and office building for Citadel Federal Credit Union located at 1209 West Chester Pike. This site is the previous location of the Ground Round restaurant.

A plan may be viewed, by request, by contacting West Goshen Township.

Recent Ordinance Changes

- On May 21, 2008, Ordinance 04-2008 was approved which amended the West Goshen Township Code, Chapter 12, Titled "Planning Commission", specifically sections 12-2 and 12-3, to increase the number of people on the planning commission from seven to nine members.
- On May 21, 2008, Ordinance 05-2008 was approved which amended the West Goshen Township Code, Chapter 70, titled "Streets and Sidewalks", specifically Article I, titled "Street Obstructions and Openings," to establish new procedures for the excavation and restoration of Township roads when a highway occupancy permit is issued.

Zoning Housekeeping Requests


- Grass/Weeds Please keep in mind that grass/weeds are to be cut on a regular basis throughout the growing season. West Goshen Township maintains an ordinance whereby growth shall not exceed twelve inches of height before a violation notice will be issued.
- Garage Sales All signs pertaining to a garage/yard sale must be removed immediately following the event. NO signs are permitted on telephone poles.
- Home Occupations Please be advised that West Goshen Township requires that any home-based business or occupation be registered with the Township.
- **Sheds** A permit is required for a shed, which must be at least six feet from the property lines. A shed may not be placed in a front yard.
- **Block Parties** As with yard sales, it is a good idea to notify the Township

when you are planning to block off your roadway for such an event. Written notification stating the date and time of your proposed block party, as well as information pertaining to a raindate, should be submitted along with signatures of those homeowners whose properties will be affected by such a closure. The Township will acknowledge your event and notify the West Goshen Township Police Department. Be sure that emergency vehicles can get through on the streets involved in your block party at all times. Off-street parking is suggested, if possible. In accordance with the Pennsylvania Vehicle Code, no vehicles may be parked within twenty feet of the intersection.

- Noise In general, it is a good idea to be mindful of your neighbors. Please keep the noise level/disturbances to a minimum. The West Goshen Township Code limits disturbing noises between the hours of 7:00 AM and 10:00 PM.
- **Pools** Any pool over 24 inches high requires a permit. If you are installing an in-ground pool it will require a building permit and a Grading, Drainage, and Erosion Control Permit.

The West Goshen Public Works will be repaying roads this year, to ease the process, and as a general rule, please follow the guidelines below:

- Mailboxes Mailboxes are to set back four to six inches from the edge of the curb.
- **Trees** All tree limbs, shrubs, etc. which are protruding into the roadway, must be cleared a distance of three feet from the road and fifteen feet up. ★



Safety Tips by Fire Marshal Andrea Testa Clothes Dryer Precautions

Your dryer has all of the ingredients to start a major home fire: heat, fuel, and air. Follow these precautions to help prevent fires:

- Clean the lint screen before or after drying each load of clothes.
- Clean the dryer vent and exhaust duct periodically.
- Ducts should not be connected by sheet metal screws or other fasteners that will obstruct the exhaust flow.
- Pull out the dryer occasionally to vacuum away any lint behind or underneath the dryer.
- Replace plastic or foil, accordion-type duct material with rigid or corrugated semi-rigid metal duct.

- Make sure that the dryer is plugged into a suitable outlet for its electrical needs as to not overload the electrical outlet.
- Always turn the dryer off when leaving home.
- In the winter make sure the dryer vent flaps are not frozen shut.
- A dryer is an electrical (or sometimes gas) appliance, make sure it is serviced by a professional only.
- Have a functional smoke detector placed in or near the laundry room. *

Road Rules

In each issue of the Township Newsletter, the West Goshen Police Traffic Safety Unit will provide information on sections of the Pennsylvania Vehicle Code that may inform readers on the requirements of these sections and the penalties for violating these sections.

Buckle Up PA is a project funded

through the Pennsylvania Department of

Transportation dedicated to raising the seat belt usage level in Pennsylvania through increased enforcement, public awareness and education.

The partnership is comprised of municipal police departments, the Pennsylvania State Police, PennDOT, the US Department of Transportation and community groups and organizations. The West Goshen Police Department will again be participating in these efforts by conducting seat belt checks throughout the year.

Section 4581 of the Pennsylvania Vehicle Code defines requirements for occupant restraint systems. Drivers are reminded that:



- All drivers are responsible to secure children from birth to age 4 in an approved child passenger restraint system.
- All drivers are responsible to secure children from 4 years of age up to 8 years of age in a seat belt system and an appropriately fitting child booster seat.
- Driver and all front seat passengers must be restrained.
 - Drivers are responsible for themselves and to secure all children from 8 years of age up to 18 years of age in a seat belt system anywhere in the vehicle.
- A driver who is under 18 may not operate a motor vehicle in which the number of passengers exceeds the number of available seat belts in the vehicle.

Certain exemptions are allowed under the law. Guidelines have been prepared by the Department of Transportation to provide guidance for these exemptions. In West Goshen Township, the Goshen Fire Company provides fire and ambulance services to the areas east of Phoenixville Pike and Route 202.

The Goshen Fire Company was started in 1950 by a group of concerned citizens. In 1952, the fire company moved into its current station located on Park Avenue. Over the years, this station has been renovated to house the growth of the company. Along with the new station, the Goshen Fire Company began providing ambulance service to the community in 1952. As call volume grew, the fire company expanded by adding a second station on the property of Hershey's Mill Village to cover the northern portion of the territory in the 1970's.



Today the Goshen Fire Company operates out of two stations, one at the original Park Avenue location and a second, constructed in 1999 in West Goshen Township, at the corner of Boot and Greenhill Roads. The fleet of the fire company has grown as demand for emergency services has increased. Today's fleet consists of four ambulances, three fire engines, two command vehicles, a tower-ladder truck, a quint specialty unit, a heavy rescue, a brush truck, and a traffic control unit. The Goshen Fire Company is a combination company, comprised of volunteers and full and part-time paid



staff used to supplement volunteers during peak call periods. The Goshen Fire Company is always accepting applications for new volunteers, including both active crew (fire, ambulance, fire police) members and administrative volunteers to assist with behind the scenes necessities.

For 2008, the Goshen Fire Company is on pace to handle close to 900 fire/rescue calls and over 3,100 ambulance calls. The Goshen Fire Company also staffs a fire police corps which is called upon to assist with traffic control at emergency scenes as well as at large community events. In addition to providing emergency services, the Goshen Fire Company is involved in various community services such as providing fire prevention talks at local elementary schools; DUI awareness presentations at local high schools; ambulance and fire engine stand-bys for a variety of community events; tours and fire prevention presentations for community groups at the fire houses; providing an educational center for various emergency services; and an annual Fire Prevention Open House, which will take place on October 10th this year.

The Goshen Fire Company prides itself on its training. Members of the fire, ambulance, and fire police divisions each are highly trained before they are approved for active duty, and have the opportunity to continue their training through various education avenues. Members participate in both in-house training sessions held weekly and in specialty training provided by outside agencies. The fire company pays for all training provided to the fire company members. To provide these emergency and nonemergency services, the Goshen Fire Company holds numerous fundraisers throughout the year. These fundraisers include the Goshen Country Fair, scheduled this year for July 28th through August 2nd. The Goshen Country Fair was originally started in 1949 to raise money to start the fire company and continues today to be a large financial supporter of the company. Other fundraisers include a fifteen-week club raffle held in the Fall, an annual winter letter drive, two

flower sales (Easter and Mothers' Day), a monthly buffet breakfast hosted by the ladies auxiliary, and the sale of Goshen Fair Doughnuts at various community



events. The Goshen Fire Company also generates revenue from renting out its banquet hall, Supplee Hall, as well as through general donations from the community.

In addition to providing emergency services to residents and businesses in West Goshen Township, Goshen Fire Company is also the primary emergency service provider for most of East Goshen township, half of Westtown Township and a portion of Willistown Township.


Cape Cod in the Fall
