Free Services Offered by Your West Goshen Police Department

West Goshen Township has one of the most highly trained police forces in Chester County. In addition to patrolling, solving crime, and ensuring safe traffic, the Police Department offers a number of free services to Township residents.

■ Prescription Medication

Collection Box: Expired or unused prescription medication can pose a hazard to curious children or pets or people looking to get a cheap but dangerous high. Placing these drugs in the trash will not remove their destructive potential, and flushing them down the toilet may contaminate the water supply.

According to West Goshen Police Captain Gregory Stone, "We are seeing a big increase in prescription drug abuse by teenagers, and we encourage you to get these prescription drugs out of your home."

Thanks to a grant the Chester County District Attorney's Association acquired, the West Goshen Police Department has a dropoff box in the

lobby of the Police
Building where these
drugs may be
deposited for disposal.
The drugs will then be
safely incinerated.
Medicines may be
dropped off whenever
the Police Building
lobby is open,
Mondays through
Fridays 7:00 AM until
11:00 PM.



■ Child Safety Gun Locks: According to the study "Firearm Deaths and Death Rates, 1999-2010," 785 children age fourteen and under died from unintentional firearm deaths during those twelve years. To help encourage gun safety in homes, The West Goshen Police Department has free child-safety gun locks available to Township residents thanks to Project ChildSafe, a program administered by the National Shooting Sports Foundation and funded by the U.S. Department of Justice.

"It is a program that can literally save lives," says West Goshen Police Chief Joseph Gleason.

West Goshen residents may request gun locks at the dispatch window of the West Goshen Police Building during regular building hours, Monday through Friday, 7:00 AM until 11:00 PM. In addition, gun owners may pick up free literature about firearms safety from the Police Department.

■ Used Cell Phones: Did you know that cell phones, even without a service plan, can dial 9-1-1 in the event of an emergency? You can put your old cell phone to good use. The West Goshen Police Department collects old cellular phones to be donated to a local women's shelter so they may have access to emergency services when

needed. Just drop off any used cell phones and accessories at the West Goshen Police Department any Monday through Friday, 7:00 AM until 11:00 PM.

- Juvenile Relations: In addition to visits to local schools, the Juvenile and Community Relations Division also provides a Pledge of Safety Certificate for children, and child fingerprint and DNA kits.
- Car Seat Check: According to the National Safety Council, automobile accidents are the number one killer of children ages three to fourteen in the United States. The Council estimates that three out of four child safety seats in use in the United States are improperly installed. In 2009, the National Highway Transportation Safety Administration issued its report "Drivers' Mistakes When Installing Child Safety Seats," stating:

"If drivers were aware that their installation was incorrect, they may seek help to fix the problems. However, drivers may not know that the CRS (Child Restraint System) installation was incorrect. The level of disconnect between the participant's assessment on a child seat installation is noted in studies showing high

Subdivision and Land Development Report

The following plans remain under review:

1320 Pottstown Pike

A seventeen lot single family detached residential subdivision is proposed on the western side of Pottstown Pike just north of Burke Road.

Traditions of West Goshen

Location: 1299 Boot Road A 43.671 square foot independent living facility consisting of 114 units is proposed.

Fernhill Elementary School

Location: 915 Lincoln Avenue This plan proposes a 14,014 square foot classroom addition, a 2,040 square foot cafeteria addition, and the enclosure of the existing front entrance of the school; also an additional 64 parking spaces will be created adjacent to the proposed classroom addition with a pickup and dropoff area. A new ten

foot wide bus stacking lane is to be created for pickup and dropoff in front of the cafeteria.

WAWA/CVS/Bank

Location: 1010 West Chester Pike Plan proposes to demolish the existing building (Thomas Chevrolet)and construct a 5,102 square foot convenience store, a 14,600 square foot pharmacy, and a 3,650 square foot bank.

Three-Lot Subdivision

Location: East Side of Pottstown Pike, South of Greenhill Road The proposed plan will create a threelot single family detached dwelling subdivision. An existing house is to remain on one of the lots.

The Woodlands at Greystone

Location: Northwest corner of the Route 322 By-Pass and Phoenixville Pike The submitted plan proposes for the development of 598 dwelling units

pursuant to the Flexible Design Conservation District regulations for a 446+ acre property located along Pottstown Pike, Phoenixville Pike, and the Route 322 Bypass (commonly referred to as the Jerrehian tract).

Goshen Leisure Development II

Location: 21 Hagerty Boulevard: East of Route 202, North of Hagerty Boulevard The proposed plan reflects 164,150 square feet of flex office and warehouse buildings to be located at 21 Hagerty Boulevard.

415 Goshen Road Subdivision

Location: 415 Goshen Road The proposed plan will subdivide the property located at 415 Goshen Road into five single family lots.

Getting to the Root of a Healthy Yard

Spring is a great time for planting! Not only do plants add to the beauty of yards and landscapes, but they can help reduce stormwater pollution. To help keep our streams and groundwater safe, try planting deeprooted plants. Deep-rooted and well adapted trees, shrubs, grasses, and garden plants prevent unwanted erosion and buffer the harmful impacts stormwater runoff can have

on stream health and drinking water supplies. Deep-rooted plants and grasses also tend to be more drought resistant, as their deeper roots allow them to tap into deeper groundwater.

Tomatoes, pumpkins, parsnips, winter squash, and asparagus are some examples of common garden plants with deeper roots. Trees and shrubs offer deeper roots; however make sure to plant at least two to three feet from any buildings or paved surfaces to allow roots to spread without structural damage. Perennials tend to have deeper root systems than annuals, and don't require yearly planting.

With some planning, you can have a beautiful, healthy, and environmentally friendly yard. ★

Handle with Care

Remember never to dispose of toxic chemicals in your household plumbing. Most toxic chemicals may be disposed of at any of Chester **County's Household Hazardous Waste** Disposals. (See "How to Dispose of Trash, Recycling, Yard Waste, and Household Hazardous and Electronic Waste" in the enclosed Trash and Recycling Guide.) Make sure you handle, store, and dispose of any toxic products such as herbicides, oil and grease, detergents and degreasers, batteries, fuels, and lubricants with caution. Not only may accidental spillage be dangerous to your family and pets, chemicals coming into contact with soil or paved surfaces migrate with stormwater into streets, storm drains, and streams as well as groundwater, polluting our precious water supplies. Be conscientious and conservation-minded when using toxic products. ★

Burning Prohibited in West Goshen Township

This winter provided many homeowners with tree limbs and branches scattered on their property. West Goshen Township residents are reminded that in 2010 the Board of Supervisors enacted an ordinance amending Chapter 31 of the West Goshen Township Code. This ordinance prohibits burning of leaves, branches, and other yard waste. Below is a section of that ordinance. If you have any questions about burning, please contact Fire Marshal Andrea Testa at 610-696-5266, ext. 4113.

31-1. Burning prohibited.

"It is unlawful to burn or to authorize another to burn any materials, natural or man-made, including but not limited to, leaves, twigs, trees, brush, lumber, building materials, construction waste materials, municipal waste, recyclable materials and any commercial or industrial by-product waste materials of any kind, outdoors anywhere within West Goshen Township." *

Make Sure Emergency Services Can Find Your House



Displaying house numbers properly is important for receiving deliveries, making it easy for friends and relatives to find your house if they haven't been there before, and for quick response in emergency situations. Because you're so familiar with your house number, sometimes it's difficult to notice if the number is not displayed very well. Many houses have numbers that are barely visible, particularly in the dark. It's best to have the number in the most obvious places people look—on the sides of a street mailbox and above or next to the front door. The numbers should be at least three inches high. Display that number properly if you want that pizza delivered on time! *

confidence levels despite mistakes made. In a report by National Safe Kids Campaign (NSKC), 96 percent of parents believed they installed their child seat correctly. However, data from child seat checkup stations consistently show that four out of five participants unintentionally made potentially hazardous installation mistakes."*

To assure the safety of children in car seats, the West Goshen Police Department's Traffic Safety Unit partners with the Chester County Highway Safety Project to offer free car safety seat checks at the West Goshen Municipal Complex twice per month. Residents of West Goshen Township can call Charlie Vilotti of the Chester County Highway Safety Project at 610-906-2711 to set up an appointment with professionals trained in correct child restraint system installation to make sure their seats are correctly installed.

"I can't stress enough the importance of a properly installed car seat in the event of a collision," emphasize Sgt. Justin DiMedio of the West Goshen Police Department's Traffic Safety Unit. *

Have Fun Outside with the Summer Recreation Program



Children between the ages of five and twelve are encouraged to run, hop, skip, and jump their way to a fun, safe, and healthy summer outdoors with the Summer Recreation Program! The 2014 Summer Recreation Program will begin on Monday, June 23rd and continue eight weeks through Friday, August 15th. The Summer Recreation Program is held weekday mornings between 9AM and noon at three beautiful West Goshen park locations. Parents may choose between Barker Park, Coopersmith Park, and West Goshen Community Park for their child(ren) to participate in a variety of fun, supervised activities.

Children will participate in a combination of structured outdoor activities and free play in a safe and fun environment supervised by our counselors. In addition, participants are encouraged to try new group activities, to be creative, and to use their imaginations in a social environment with other children. Children will have opportunities to play sports such as soccer and lacrosse, play games such as tag and dodgeball, enjoy the playground and sports facilities, make crafts to take home such as their own tie-dyed shirt.

Participants can also join in eight weekly field trips with enjoyable and supervised activities including swimming, bowling, roller skating, ice skating, and more! Four of the trips are included in the registration fee and the remaining four require an additional fee per trip which includes the activity, adult supervision and bus transportation (for most trips).

Parents may register their child(ren) for one of the three park locations during the mornings of Saturday, May 10th (8:00 – 11:00 AM) and Saturday, May 17th (9:00 – 11:00 AM) at the West Goshen Township Administrative Building with Township residents having first priority. Beginning on Monday, May 19th, registration will continue during normal business hours (7:00 AM – 5:00 PM) as space permits. Registration is for the entire eightweek program.

The program fee for West Goshen families continues to be \$200 for the first child, \$350 for two children, and \$100 per additional sibling for the eight-week program. West Goshen residents are able to register children for both the Summer Recreation Program and the Summer Teen Program (see page 9) while taking advantage of the discounted rate structure. Proof of residency must be provided (e.g., drivers' license, sewer bill, address on check) to be eligible for resident rates. The registration fee for residents of other municipalities continues to be \$300 per participant. Only personal checks or cash will be accepted. Children must be five years old by September 1, 2014 to register and should be comfortable participating in a group environment. Parents must bring a copy of their child(ren)'s birth certificate or other proof of age.

Learn About The Philadelphia Campaign of 1777 and West Goshen's Role in the American Revolution

Monday, June 23rd at 7:00 PM at the West Goshen Township Administration Building

ean Moir, owner and president of Western Heritage Mapping in Valley Forge, will present a program at the West Goshen Township Administration Building on Monday, June 23rd at 7:00 PM describing Revolutionary War troop movements in Chester and Delaware Counties as part of the Philadelphia Campaign, which included the Battle of the Brandywine, the Battle of the Clouds, and the Paoli Massacre.

Moir's presentation establishes the context of the Philadelphia Campaign within the American Revolution, and uses unique animated maps to help tie these events to local sites.


As part of a multi-award winning county project, sponsored in part by the National Park Service and the American Battlefield Protection Program, Moir has worked for the last three years researching, mapping, and animating the conflicts of the 1777 Philadelphia Campaign. In addition to his work in Chester County, he has done work for the Pencader Heritage Area Association in Delaware (site of the Battle of Cooch's Bridge), the Cliveden House in Germantown (site of the Battle of

Germantown), the Friends of Valley Forge Park, and currently has an animated map on exhibit at the American Swedish Heritage Museum showing the growth and development of the New Sweden settlements in the seventeenth century.

The Battle of the Clouds, which took place in part in East and West Goshen, is currently the focus of research being conducted by the West Goshen Historical Committee. Permanency Partners

Permanency Partners, started in West Goshen Township in 2010 to replace the foster care and adoption programs previously provided by the Friends Association for the Care and Protection of Children, is a division of Children's Home of York. Permanency Partners provides a variety of services for children and their biological, foster, and/or adoptive families from birth through the age of eighteen. Permanency Partners, licensed by the Commonwealth of Pennsylvania, is an affiliate agency of the Statewide Adoption Network (SWAN).

According to LaToya Pollitt, Permanency and Resource Coordination Supervisor for Permanency Partners, while many people are interested in adopting newborns, often children most in need of a home are those above the age of ten, children with special needs, or siblings looking for a home together. As an incentive, the state of Pennsylvania will assume the \$2,500 fee to create a family profile for adoptive parents looking for children in any of these categories.

Pollitt also indicates a great need for foster families. Children in foster care often find themselves endangered by parents with drug addictions, untreated mental illnesses, or parents who are abusive or homeless or otherwise unable to care for their children. Although the County will provide counseling and other assistance to help biological parents reunite with their children, sometimes this is not possible and the children may eventually end up being adopted by their foster families.

Once parents have completed the adoption process, Permanency Partners offers a continuation of services known as Post-Permanency Services which include case management, assessment, support groups and respites. Permanency Partners also offers monthly training and support groups for all foster and adoptive parents free of charge.

"One of the greatest things is our retention events," says Pollitt. These quarterly events bring adoptive and foster families together for social outings such as bowling, hayrides, laser tag, or an annual appreciation banquet. These events are free of charge to the families. During the Christmas season, Permanency Partners hosts a Christmas party for foster and adoptive families, and provides gifts for each of the children they helped find homes for.

Apply Now for the Pennsylvania Property Tax Rebate to Be Eligible for the West Goshen Township Trash Rebate

Eligible senior citizens are advised to apply now for the Pennsylvania Property Tax/Rent Rebate in order to be eligible for the West Goshen Township Trash Rebate Program. To determine eligibility, seniors must meet the following requirements:

- Qualified applicants must be 65 or older as of December 31, 2013.
- Applicants' 2013 household income, including 50% of Social Security payments, must equal \$35,000 or less.

Pennsylvania residents who meet these qualifications may apply for the Pennsylvania Property Tax/Rent Rebate by June 30, 2014. Applications for the Pennsylvania Tax/Rent Rebate Program may be obtained from the Chester

County Department of Aging Services, 601 Westtown Road, Suite 320, West Chester, PA 19382 (610-344-6350), or by visiting www.revenue.state.pa.us/portal/server.pt/community/property_tax_rent_rebate-program/11410/sign-up_to_receive_a_form/581708.

West Goshen residents receiving the Pennsylvania Property Tax/Rent Rebate must make a copy of that check to attach to the West Goshen Township Trash Rebate Program Application. The Trash Rebate Program Application is available at the West Goshen Township Administration Building and must be completed and returned to West Goshen Township by October 31, 2014. First time applicants may receive copies of the West Goshen Trash

Rebate Program by calling 610-696-5266, ext. 4108 or by visiting www.westgoshen.org.

First time applicants for the West Goshen Township Trash Rebate Program must bring identification along with a copy of the Pennsylvania Property Tax/Rent Rebate check. The social security number and date of birth for Property Tax/Rent Rebate applicants may be used if the rebate was paid via direct deposit instead of check.

Pennsylvania Property Tax/Rent Rebates will be mailed or direct deposited beginning July 1, 2014. West Goshen Township Trash Rebate checks will be mailed in December 2014. ★

ROAD RULES

Pedestrian Safety

With the arrival of spring comes an increase in pedestrian traffic. Unfortunately, pedestrians were one of the few groups of road users to experience an increase in fatalities in the United States in 2011, totaling 4,432 deaths (14% of all highway deaths, an increase of 3% from 2010), according to the National Highway Transportation Safety Administration (NHTSA). To help reduce the dangers of being a pedestrian, remember these safe walking tips:

- Be predictable. Follow the rules of the road and obey signs and signals.
- Keep alert at all times; don't be distracted by electronic devices that take your eyes (and ears) off the road.

- Cross streets at crosswalks or intersections whenever possible. This is where drivers expect pedestrians.
- Look for cars in all directions including those turning left or right.
- If a crosswalk or intersection is not available, locate a well-lit area where you have the best view of traffic, wait for a gap in traffic that allows you enough time to cross safely, and continue to watch for traffic as you cross.
- Walk on sidewalks whenever they are available.
- If there is no sidewalk, walk facing traffic and as far from traffic as possible.
- Never assume a driver sees you.
 Make eye contact with drivers as they approach you to make sure you are seen.

- Be visible at all times.
 Wear bright clothing during the day, and wear reflective materials or use a flashlight at night.
- Watch for cars entering or exiting driveways, or backing up in parking lots.
- Avoid alcohol and drugs when walking; they impair your abilities and judgment. *



In each issue of the Township Newsletter, the West Goshen Police Traffic Safety Unit will provide information for drivers, focusing on sections of the Pennsylvania Vehicle Code or other traffic safety issues.

Magisterial District Judge Kraut Delivers State of the Court Address

This spring, Magisterial District Judge William Kraut of District Court 15-2-03, which encompasses West Goshen, Westtown, and Thornbury Townships, presented his annual State of the Court Address to residents of West Goshen Township in which he affirmed "I am committed to continuing to protect and strengthen our community in the coming year."

Judge Kraut points out that Magisterial District Court 15-2-03 is the third busiest of eighteen courts in Chester County, and that the District Court is "solid, sound, stable, and will remain intact after the statewide redistricting."

The State of the Court Address describes Magisterial District Courts as "Courts with limited jurisdiction," explaining, "More than 90% of all litigation in Pennsylvania occurs in the courtrooms of Magisterial District Judges," and continuing: "All summary misdemeanor and felony criminal cases originate at the Magisterial District Court level. Magisterial District Courts are also the venue for lawsuits in civil cases for matters up to \$12,000.00 as well as the

filing and disposition of minor criminal cases (summary cases) such as traffic violations, disorderly conduct, public drunkenness, truancy, game law violations, and parking tickets."

According to the State of the Court Address, responsibilities of a Magisterial District Judge include conducting preliminary hearings for all serious criminal offenders to determine which cases should be held for trial at the Court of Common Pleas, setting and accepting bail and arraigning defendants after arrest, and issuing search warrants based upon testimony from local or state police or the state's Attorney General's office.

Magisterial District Court 15-2-03 handled 7,287 cases in 2013, including:

- 356 criminal cases
- 1202 summary cases
- 5,285 traffic cases
- 233 civil cases
- 202 landlord/tenant cases

The District Court collected \$1,149,563.25 in fines. Of that,

West Goshen Township received \$152,344.35.

Judge Kraut invites residents of West Goshen, Westtown, and Thornbury Townships to visit his office with any suggestions on making the court run more efficiently or how the court can better serve the public. He cautions, however, that he is unable to discuss a case he is about to hear, and that neither he nor his staff may give any legal advice to the public. Tours of the Court are available for schools and scouts, and Judge Kraut welcomes requests from schools, scouts, and civic groups for him to speak. Magisterial District Court 15-2-03 is located at the Chester County Government Service Center at 601 Westtown Road, Suite 110 in West Goshen Township Mondays through Fridays 8:30 AM until 4:30 PM. ROONIE SAYS...

est Goshen Township opened Roonie's Canine Corner at Robert Lambert Park in the summer of 2006. Since then, the Park and Recreation Department has answered numerous questions from dog owners visiting the dogpark. Here are some of the most frequently asked questions:

Are pit bulls allowed in Roonie's Canine Corner? Yes. A properly trained pit bull (American Staffordshire Terrier or Staffordshire Bull Terrier) is able to interact with other people or dogs without posing any threat. It is the responsibility of the dog's owner to make sure his or her dog is able to socialize safely with other dogs before entering the dogpark. West Goshen Township does not discriminate against any dog who meets this condition.

What should I do if I or my dog is attacked by another dog?

Get contact and immunization

Get contact and immunization information from the owner of the offending dog and get medical attention immediately if needed. If the owner is uncooperative, contact the West Goshen Police Department by calling 9-1-1, and make a record of the time and date of the incident, pertinent physical descriptions of the

dog and owner, and the owner's license plate number.

Why is the dogpark closed weekdays between 10:00 and 11:30 AM? The West Goshen Parks Department needs to devote time to maintain the dogpark. Some equipment, including mowers and weedwhackers, tend to spook some dogs, creating a hazard for our staff.

I left a water bowl/tennis ball/etc. at the dogpark but it wasn't there when I returned. What happened to it? Our maintenance crew will periodically dispose of objects left in the dogpark as they can potentially pose a sanitary threat when used by multiple dogs.

My dog was just playing with another dog, and that owner accused my dog of acting too aggressively and asked me to restrain my dog. Do I have to oblige? Yes. Even if dogs are just playing, each owner has the right to determine the interactions of his/her dog. If an owner does not want your dog interacting with his/hers, you would have

the obligation of restraining or removing your dog.

What is the danger of not bringing a spayed or neutered dog into the dogpark? Dogs who are not spayed or neutered may display unwanted aggressive and/or sexual behavior such as mounting or fighting. Dogs in heat should never be brought to the dogpark, and the Park and Recreation Department strongly recommends not bringing your dog to Roonie's Canine Corner until it has been spayed or neutered.

Is there a time I may bring my small dog to the park when bigger dogs will not be

there? No. Roonie's Canine Corner is open to all dogs regardless of size or breed. Many small dogs enjoy playing with larger dogs and vice-versa. If your dog is not comfortable with dogs of different sizes or breeds, try returning at a different time, but we can not guarantee a time for just small or big dogs. *

The following guide for disposing of recyclables, household hazardous wastes, and other trash items is for homeowners not affiliated with a homeowners association in West Goshen Township.

Residential establishments with four or more units and commercial, municipal, and institutional establishments are responsible for individually contracting at their sole cost and expense for the collection of waste and recyclables with any collector/hauler licensed by West Goshen Township.

Recyclables (Mondays):

There is no maximum limit. The following items are recyclable:

- · Cans, including aluminum, steel or tin.
- Bottles and jars, including clear, brown, or green glass.
- Plastics, #1 through #7
- Flattened boxes, including cereal boxes, corrugated cardboard, and other cardboard boxes Please note that all cardboard items must fit into your recycling bucket. Cardboard must be cut into pieces no larger than two feet by two feet, and bagged or bundled into stacks no larger than one foot thick.
- · Paper, including junk mail, telephone books, catalogs, white paper, wrapping paper, magazines, and newspapers

All items must be placed in a West Goshen Township plastic recycling bucket or a trash can with a Township recycling sticker affixed to it. Recycling stickers are free and may be obtained from the Township. If you have moved into new construction, you may obtain a recycling bucket at no cost at the Township Administration Building. Twenty gallon recycling buckets are available for purchase (\$10 each) at the Township Administration Building. Mark each bucket with your street and house number. Place at curbside before 6:00 AM or the night before. Recycling buckets must be placed to the left or right of trash cans, with at least three

feet of clearance between the containers.

The following items are NOT recyclable and should be disposed of with regular trash:

- Tissues, paper towels, and napkins
- Food wrappers
- Wax or plastic coated boxes
- Tyvek envelopes
- Metallic wrapping paper
- Light bulbs
- Plate glass, window glass, drinking glasses, or mirrors
- Crystal
- Ceramics
- Aerosol paint cans
- Ovenware
- · Plastics without identifying recycling numbers
- Empty oil cans or bottles
- Styrofoam

Trash (Mondays/Thursdays):

The Township-provided 96 gallon containers help assure efficient trash collection. Place this container at the curbside before 6:00 AM or the night before. Trash will not be picked up after the truck has arrived.

Please follow these guidelines to make sure your trash is being picked up safely and in a timely manner:

- Your trash container has a unique identification number assigned to your home. We recommend that you make note of your toter number and indicate your address in permanent black marker on it to avoid confusing your container with those of neighbors.
- All trash (except bulk items) must be placed inside the Township-provided container.
- Place your container on the street with the front wheels against the curb and the handle and wheels facing away from the street.
- Make sure your recycling container is placed at least three feet to the left or right of the trash toter.
- Position your container so it is at least four feet away from mailboxes, cars, or any other obstacles.

Bulk Trash (Thursdays): A maximum of one bulk item will be collected per week. A bulk item is an object which

two people can lift. Disabled refrigerators, air conditioners, and other cooling units must be tagged that freon has been removed. Refrigerators must have front doors removed. No building materials, railroad ties, automotive parts, or tires will be picked up. A maximum of four carpet rolls, each no longer than four feet in length, will be collected.

Yard Waste: West Goshen Township provides monthly yard waste service to residents between April and October on the dates indicated on the next page. Homeowners may place leaves, branches, twigs, and other yard wastes in trashcans or biodegradable paper yard waste bags, or tied in bundles no more than four feet in length with branches no more than four inches in diameter at their curbside for collection. Yard waste will not be collected from plastic bags, and grass clippings will not be accepted. There is no limit to the number of trash cans, paper bags, or tied-up bundles that will be accepted.

In compliance with standards set by Title 25 of the Pennsylvania Code, yard waste is no longer permitted to be burned in West Goshen Township.

No Trash Service: If a collection day for regular trash, recycling, or bulk pickup falls on a holiday, collection will occur on the very next day. If the holiday falls on a Monday, the second pickup that week will also be postponed from Thursday to Friday. Midweek holidays may result in trash being collected on Fridays instead of Thursdays.

Household Hazardous and Electronic

Waste: Items labeled with any of the following words can not be disposed of with regular trash: CAUTION, TOXIC, DANGER, FLAMMABLE, WARNING, CORROSIVE, EXPLOSIVE, REACTIVE, COMBUSTIBLE, POISONOUS, or HAZARDOUS. Explosives, ammunition, radioactive wastes, and infectious or unidentified wastes will not be accepted for disposal. Please contact the proper authorities if you have a waste item that poses a significant danger. Use the chart on reverse page to determine items that may be brought to the Chester County

Latex paints will not be accepted—they may be air dried or mixed with cat litter and disposed of with your regular trash pickup. Motor oil and tires will not be accepted, but may be brought to your local service station. Call 610-273-3771 for locations for automotive related materials.

Please pack all household hazardous wastes safely in original containers for transport. ★

Minimum Institutional Recycling Requirements

ach owner, operator, or administrator of a school, hospital, nursing home, public agency, restaurant, store, office building, factory, shopping center, condominium, apartment building, or homeowner association must provide for collection of the following recyclable materials at least once a month:

Businesses: Corrugated, white bond/copier/letterhead, and computer paper; aluminum, steel, and bimetallic cans.

Multi-unit residences: Clear and colored glass; aluminum, steel, and bimetallic cans; #1 and #2 plastics; mixed paper including newspaper, junk mail, telephone books, catalogs, white paper, magazines, flattened boxes which do not come into direct contact with food; non-corrugated cardboard. Check with your apartment complex or homeowners association to determine which materials to recycle.

Owners, operators, or administrators of these properties must provide easily accessible and suitable recycling containers and written instructions to each occupant, employee, patron, or resident which clearly describe what materials are to be recycled, how the materials are to be prepared, and how the collection system works. Educational facilities must provide for separation and collection of recyclable materials in classrooms, administrative offices, cafeterias, and dormitories.
