West Goshen Township Welcomes Two New Supervisors

Christopher Pielli, Esq. and Hugh J. Purnell, Jr. joined the West Goshen Township Board of Supervisors at the January 4, 2016 Township Organization Meeting after each was elected in November 2015.



"My advice to West Goshen residents is to get to know your neighbors. They are a treasure!" —Christopher Pielli, Esg.

A native New Yorker, Chris Pielli moved to the West Chester area in 1981 when his father, a retired firefighter, became a teacher at Fugett Middle School. Except for a stint in the U.S. Army and studies at Temple University, Pielli has lived in the West Chester area since then, moving into West Goshen thirteen years ago, where he and his wife Christine have raised their two children, Andy and Angelina. A practicing lawyer since 2000, Pielli opened his own practice in 2004 to serve the community's legal needs in the areas of criminal, family, traffic, and various civil law matters. He is a long time arbitrator

for the Chester County Court of Common Pleas arbitration panel and a substitute Solicitor for the Chester County Mental Health Court. Elected a Democratic State Committeeman in 2014, Pielli ran for Supervisor in 2015 to protect the quality of life West Goshen residents deserve and have come to expect by properly planning for the future both fiscally and developmentally.

"During the campaign, I knocked on over 1,300 doors and had the opportunity to meet a lot of fantastic and interesting people," says Pielli. "No matter if they were Republicans, Democrats, or Independents, they all seemed to share a strong sense of community and a willingness to engage in meaningful dialogue."

Pielli adds: "To me it's simple: It's not about politics, it's about families and homes."

Hugh J. Purnell, Jr., a lifelong resident of the West Chester area, has, with his wife Shelagh, called West Goshen Township home since 1969. Hugh

Patricia B. McIlvaine has served on the West Goshen Board of Supervisors since 2002, after her election as the Township's first female supervisor in November 2001. Prior to that, she had served as West Goshen's tax collector, and had served on the West Chester Borough Council prior to moving to West Goshen Township. A nurse by training, McIlvaine also served as a legislative aide to State Representative Elinor Z. Taylor between 2000 and 2007.

McIlvaine's responsibilities on the Board of Supervisors included serving as the first female Board Chair, and representing West Goshen Township on the West Chester Counsel of Governments (WCCOG).

"She loved interacting with officials from surrounding townships," says

current Board Chair Raymond H. Halvorsen. "She always believed you accomplished great things from sharing common interests."

Theodore J. Murphy joined the West Goshen Board of Supervisors in January 2011. Having moved into West Goshen Township in 2000, Murphy had served in the U.S. Army's 82nd Airborne, graduated from Georgetown University with a degree in history and government, and earned his law degree from Temple in 1994, with a Master's in International Law from there in 2007.

"He's very intelligent," says Vice-Chairman Edwards G. Meakim, Jr., emphasizing Murphy's work on the Roslyn neighborhood traffic control and the Sunoco pipeline.

"Ted's very cerebral," agrees Chairman Halvorsen. "He's an incredible deep thinker. He really understands the mechanisms of business decisions."

Murphy will continue to serve West Goshen Township on the Sewer Authority. "I'm sure he'll help us in any other way," says Halvorsen.

Remember to file your local taxes online by April 18th at www. KeystoneCollects.com. Keystone Collections Group's e-file is easy, fast, secure, and accessible 24 hours a day. Filers will need a 2015 W-2, Social Security Number, and any other income documents that may apply (such as a PA-UE or a Schedule C). Anyone working in Philadelphia or claiming an out-ofstate tax credit may be eligible for a local earned income tax credit up to the amount owed to West Goshen Township. The worksheet on the back of the form will help calculate out-of-state tax credit.

Each year, the West Goshen Township Newsletter publishes an updated snow removal guide for property owners, with important information you should know before, during, and after each snowfall.

Before the Snow Falls...

Make sure the front of your mailbox is at least a four to six inches behind the front of the curb and mounted at a height of four feet. Mailboxes closer to the curb and lower to the ground are most likely to be damaged by the weight of snow being pushed from a plow. Take time to make sure your mailbox is sturdy enough to withstand the weight of snow being pushed into it. Make sure to clear snow from all walkways, stairs, and paths to mailboxes. For confirmed cases of mailboxes being damaged by plowing operations, West Goshen Township will provide a new black or white mailbox and a wooden post.

Trim tree branches hanging over the

road. All tree limbs, shrubs, etc. which are protruding into a roadway, must be cleared by the property owners of the trees. Trees may not extend closer than a distance of three feet from the road and fifteen feet up.

Consider installing driveway markers.

If your property does not have a curb or other method to delineate the edge of the street, orange driveway markers, available at home repair stores, can help plow drivers know where the edge of the road is and avoid damage to your property.


■ Keep cul-de-sacs and roads free of parked cars from the time snow starts until the roads are cleared. In the case of steep driveways, park at the mouth of the drive, but off the road. If a car is parked on a roadside or cul-de-sac, we may not finish plowing that street, but return several hours or even the next day to complete the work.

While Roads are Being Plowed...

Do not place shoveled, blown, or plowed snow from driveways, sidewalks, or parking lots onto public streets. This is extremely dangerous and is a violation of Chapter 70 ("Streets and Sidewalks") of the West Goshen Code, punishable by fines up to \$1,000 per day. The ordinance also prohibits piling snow into storm gutters.

When shoveling your driveway, leave the last six feet of your drive unshoveled until the plowing has ceased. This

unshoveled part will allow the snow being pushed by the plow to remain on the plow and not dumped into your drive. If you must shovel out your drive, clear a six foot area of the road that is directly in front of the mouth of your drive. In addition clear an area ten feet



before and after the mouth of your drive, so that when the plow comes through, it will unload snow that it is pushing in the cleared area and not in the mouth of your driveway. Use the above illustration as a guide for shoveling before the roadways have been cleared.


Be patient. Snow removal does take

time, especially in heavy snowfall. West Goshen Township will usually plow potentially dangerous and heavily travelled areas first. Drivers begin one pass in each direction on streets and one pass into and out of cul-de-sacs. Once an initial clearance is made on each roadway, drivers commence with the process of pushing snow back to the road's edge and cleaning out cul-de-sacs. We may not finish plowing that street, but will return several hours or even the next day to complete the work. Any residual snow will be pushed back from streets when the storm has ended.

Note that West Goshen Township does not clear all streets within the Township. The following streets are cleared by the developer or property owner: Cougar Lane, Derry Lane, Furr Avenue, Gated Lane, Hicks Road, Honeysuckle Court, Hydrangia Court, Kimes Avenue, Links Drive, Llewlyn Circle, Morning Glory Drive, McDermott Drive, Oak Circle, Peaceful Lane, Pine Circle, Prospect Avenue, Sorber Drive, Thomas Avenue, Turner Avenue, Turner Lane between Paoli Pike and West Chester Pike, S. Walnut Street, E. Washington Street between Garfield and the dead end, Woodcrest Circle, Wrights Lane, and Wisteria Lane. PennDOT clears the following streets: Boot Road, Fern Hill Road, S. Five Points Road between Westtown Road and Little Shiloh Road. Garfield Avenue between Lincoln Avenue and Paoli Pike, Goshen Road east of North Hills, Greenhill Road, S. High Street (Business Route 322), E. Marshall Street, Lincoln Avenue, Montgomery Avenue, Paoli Pike, Phoenixville Pike, Pottstown Pike, Strasburg Road, West Chester Pike (Route 3), Westtown Road, and Routes 100, 202, and 322.

Police Swear In Two New Officers, Promote Four

At a public swearing-in ceremony on Tuesday, January 5, 2016, the West Goshen Township Police Department welcomed two new officers and promoted four others.

Magisterial District Justice William D. Kraut administered the oath of office to Officers Robert Story, Jr. and Kyle Maye. Story comes to West Goshen Township after serving for eleven years in the Parkesburg Police Department. He also worked for the East Fallowfield and Kennett Square Police Departments prior to that. Officer Maye is a 2014 graduate of the Police Academy, and has earned his undergraduate degree from the University of Delaware. He also serves in the Pennsylvania Army National Guard as a First Lieutenant.

Two sergeants, Michael Carroll and Justin DiMedio, were promoted to the rank of lieutenant.

Lt. DiMedio had previously supervised the Traffic Safety Division. He first came to the West Goshen Police Department in 1995, and was promoted to the rank of sergeant in 2010. He has a bachelor's degree from West Chester University and is a graduate of the FBI National Academy. "He's highly regarded throughout the law enforcement community in the region for his expertise in accident reconstruction, his professionalism, and his work ethic," says West Goshen Police Chief Joseph Gleason. Lt. DiMedio's new responsibilities will include overseeing patrol, administration, and accreditation.

Lt. Carroll worked with the detectives prior to his promotion, as well as serving as an active threat instructor for the county under the Chester County Chiefs of Police and the District Attorney's Office. Carroll began working for the West Goshen Police Department in 1996, and joined the Criminal Investigations Division in 1999. He was promoted to the rank of sergeant in 2008. He also has a bachelor's degree from West Chester University and is a graduate of the FBI National Academy. Chief Gleason emphasizes the gualities Carroll will bring to his new position: "He's probably one of the most intelligent officers I've ever met," he said, adding, "He has excellent leadership skills." As a lieutenant, Carroll will supervise operations with regard to investigations, juvenile and community relations, the emergency response team, and training with an emphasis on firearms training.

Officer Darren Sedlak was promoted to the rank of sergeant at the ceremony. He will oversee the Criminal Investigations Division. Sedlak has served on the Patrol, Traffic Safety, and Criminal Investigation Divisions since joining the West Goshen Police Department in 1997.

"If I were ever to commit a crime, Darren is the last officer I would want on my case," says Chief Gleason. "Darren is relentless."



"He has a gift for criminal investigation," adds Captain Greg Stone.

Newly promoted Sgt. Brian Griesser will oversee the Traffic Safety Division. Since joining the West Goshen Police Department in 1999, Griesser has worked with the Patrol and Traffic Safety Divisions. According to Chief Gleason, Sgt. Griesser will bring his trademark quiet leadership to his new role: "He's very low-key. He doesn't look for the spotlight."

To achieve the rank of sergeant, officers must have a minimum of five years of non-disciplinary service, be evaluated by their supervisors, and take an oral exam with senior officers and a command staff officer from Harrisburg offering independent review. Lieutenants are executive appointments recommended by the Police Chief and approved by the Board of Supervisors.

"A police department is an investment in the safety and security of the residents who live within the community," said Chief Gleason at the ceremony. "These promotions are establishing a command structure that ensures the residents of West Goshen Township a present and future department of leadership, bar none!"

ROAD RULES

Regardless of whether there's snow on the ground, you can take steps to prepare yourself for winter and all that it brings. Preparation is key to successfully navigating winter roads. Winter weather can bring unexpected conditions, so make sure that your vehicle is ready for ice and snow.

For the majority of Pennsylvania, all-season radial tires that are mud and snow rated are appropriate for winter driving. In areas of the state that experience more snow, motorists may choose to install dedicated winter tires or carry a set of tire chains or cables.

Motorists should bring with them an emergency kit with the following items: a flashlight and batteries; a battery-operated radio; jumper cables; a cell phone and charger; a snow shovel; matches and candles; first aid supplies; extra warm clothing and gloves; a blanket; an ice scraper; sand or cat litter; bottled water; non-perishable food; anything else you may need to accommodate family traveling with you (special medication, baby supplies, pet food, etc.).

As we experience inclement winter weather conditions, the West Goshen Police Department would like to remind you to be sure to clear your vehicles of snow and ice before taking to the roads.

Section 3720 of The

Pennsylvania Vehicle Code states: "When snow or ice is dislodged or falls from a moving vehicle and strikes another vehicle or pedestrian causing death or serious bodily injury as defined in Section 3742 (relating to accidents involving death or personal injury), the operator of the vehicle from which the snow or ice is dislodged or falls shall be subject to a fine of not less than \$200 nor more than \$1,000 for each offense."

Drive carefully and please allow for extra time when driving in inclement weather conditions.

Lodge #322, West Chester Lions Club-Daytime, the Goshen Fair, the Chester County Hospital Fair, West Chester Recreation, the Friends of West Chester Parks and Recreation, the Friends of Marshall Square Park, and numerous automobile clubs. An accountant who has had his own business in West Goshen Township since 1983, Purnell has served on the Republican Committee since 1982 and was elected to three terms (eighteen years) as an Auditor for West Goshen Township.

"I love West Goshen Township," says Purnell. "I've basically lived here all of my voting life."

Purnell says he decided to draw from his experience as an accountant and

as a Township Auditor and run for Supervisor shortly after the passing of his friend, West Goshen Supervisor Dr. Robert S. White. "I had a fairly close relationship with Dr. White, especially in regards to the Township finances. I honestly thought it was necessary to have someone on the Board with financial acumen."



Safety Tips by Fire Marshal Andrea Testa

Proper Disposal of Fireplace Ashes

Each year the Fire Departments serving West Goshen Township respond to fires that are caused by improper disposal of hot coals or ashes from fireplaces, wood stoves, pellet stoves, grills, or mobile fireplaces designed for use on decks or patios.

The fact is that coals and ashes from fires can remain hot enough to start a fire for many days after you think the fire is out. The exact amount of time for complete extinguishment and cooling depends on many factors such as how hot the fire was, what was burning, how much unburned fuel remains, etc.

To be safe, simply treat all ashes and coals as hot, even when you think they had time enough to cool. If possible, allow ashes and coals to cool in the area where you had the fire for several days. These devices are designed to contain their heat safely. When it is time to dispose of the ashes, transfer them to a metal container and wet them down. Keep the metal container outside your home and away from any combustibles until the refuse is hauled away. DO NOT place any other combustibles in the metal container. DO NOT use a combustible container. They should never be disposed of in a plastic garbage bag or can, a cardboard box, or a paper grocery bag.

More Fireplace Safety Tips

 Have your chimney inspected annually and cleaned as necessary by a professional chimney sweep to ensure it is clear of obstructions and creosote.

- Repair any cracks in your chimney and fireplace.
- Use fireplace screens to keep sparks and fire debris inside the fireplace.
- Do not use an accelerant to start a fire
- Ensure the fire is completely out before going to bed or leaving the house.
- Make sure the area around the fireplace is clear of all combustibles (Three feet away is a good rule).
- Keep all children and pets a safe distance from fireplaces.
- Install both smoke and carbon monoxide alarms.
- Keep a fire extinguisher on hand.
- Observe all safety precautions when using outdoor fireplaces. They can be just as dangerous as indoor units.

Disposal Events

West Goshen residents looking to dispose of household hazardous wastes, electronic devices, or to shred home office papers may do so at the following events:

HOUSEHOLD HAZARDOUS WASTE: Chester County residents may bring household hazardous wastes for disposal to CAT Pickering, 15809 Charlestown Road, Phoenixville, PA, 19460 on Wednesday, April 6, 2016 between 9:00 AM and 3:00 PM. The county will NOT accept electronic devices at this disposal. Proof of residency may be required. Household Hazardous Waste events start at 9:00 AM and end promptly at 3:00 PM. Information about future Household Hazardous and Electronics Waste disposals will be listed in the Waste and Recycling Guide in the Spring 2016 issue of The West Goshen Township Newsletter.

ELECTRONICS: West Goshen residents wishing to dispose of electronic items may do so at the West Goshen Municipal Complex on Saturday, April 9, 2016 between 9:00 AM and noon. Plug-in and electronic devices including laptops, computers and peripherals, electric typewriters, telephones, cameras, cellular phones, calculators, small appliances, fax machines, keyboards and mice, and printers will be accepted. Smoke detectors, large appliances and projection televisions will not be accepted. A \$30 fee will be required for any glass (tube) televisions or computer monitors, and a \$10 fee will be charged for microwaves, dehumidifiers, and air conditioners. All data media will be destroyed or wiped. Items will be broken down for their components and recycled by eForce Compliance. West Goshen will also host an electronics dropoff on Saturday, November 5, 2016. This service will be restricted to West Goshen residents or to Township businesses with fewer than fifty employees.

West Goshen residents are reminded that electronic devices may not be disposed of with regular trash pickup in accordance with Pennsylvania's Covered Device Recycling Act of 2010.

SHREDDING: On Saturday, April 2, 2016 between 9:00 AM and noon, West Goshen residents can bring personal documents to the West Goshen Municipal Complex to be securely shredded and recycled, watch their items being destroyed on the shredding truck's closed-circuit monitor, and rest assured that their documents will ultimately be recycled and not added to landfill space. Items from businesses will not be accepted. Each West Goshen resident may bring up to four file boxes (9" x 12" x 18") containing paper documents. Discs, credit cards, or other non-paper items will not be accepted. A fall shredding event will take place on Saturday, November 12, 2016.


Take Advantage of a Natural Resource by Creating

Rain gardens are a natural and beautiful way to help your streams while taking advantage of an abundant natural resource, rainwater. These gardens in slight depressions in the ground trap rainfall from a roof or driveway and prevent it from adding to the polluted runoff that damages streams. Trapped rainwater is allowed to slowly sink into the ground while supporting beautiful plants that attract birds and butterflies.

You can create your own rain garden in three easy steps...

1. Pick the Right Location and Size

The best locations are in natural depressions or low lying areas where water flows naturally from a downspout, driveway, patio, or sidewalk. Avoid steep slopes and areas near septic systems or drinking water wells. You must be able to move water from the hard surface (roof, etc.) to the garden location, either by directing a downspout with an extended tube towards it, or simply by following contours and capturing water that is naturally flowing downhill. The rain garden should be at least ten feet away from any foundations or utilities and have well-drained soils that water can infiltrate within one day (thus preventing mosquitos from breeding in puddles). To test your soil, dig a small six to eight inch deep hole and fill it with water. The site should drain within six hours. The site should be large enough to handle the amount of water it will receive, and be positioned so that overflow during large storms moves away from your house.



A properly sited and prepared rain garden will not allow mosquitoes to breed. Your rain garden will drain within 24-48 hours after a storm. Mosquitoes need seven days or more to complete a breeding cycle.

Z. Create a Design and Select Plants

Once you have a location and size for your garden, sketch it out on paper. Determine the mix of species you would like to use, including flowers, grasses, and shrubs that are drought tolerant but can withstand wet conditions. Native plants are adapted to local conditions, easy to maintain and attract birds and butterflies. Fill in your sketch with your selected plants. If you are planting a mix of shrubs, flowers, and grasses, make sure that you are accounting for the location of the sun during the summer months. Shrubs and taller grasses should be positioned so that they are not blocking the sun from lower growing

sun-loving species. Most grasses and flowers should be spaced 10-12 inches apart on center.

5. Construct and Plant your Garden

Spray paint or otherwise mark on the ground the exact shape of your rain garden. Excavate to a depth of 4-8 inches, creating a berm on the downslope side of your garden using the removed sod. If the soil at the bottom of your basin is the same color and consistency as the top layer you removed, you can plant right into it. If it looks lighter, you will need to add compost, topsoil and mulch. If the soil appears compacted, you can use a tiller to loosen it. Try to keep the bottom of the basin as flat as possible to increase the area that will come in contact with water regularly. Add plants following your design, placing species that need the most water in the lowest lying areas or in the most direct path from the downspout. Water regularly during

the first year if there are long stretches without rain. Once established, your garden will not need watering or mowing. Monitor your garden regularly so that you can remove any weeds that may grow up before they spread. Mulching and planting grasses and flowers in tight bunches can minimize weed arowth.

If you are using power equipment to dig you must call 811 to have utility lines marked. Calling 811 is recommended even for hand digging. Homeowners performing work on their property are not charged for this service. Allow three business days to have lines marked.

The Chester County Solid Waste Authority will provide training, materials, volunteer opportunities, and support. Participants who attend all three classes and perform six hours of volunteer service will receive a Master Composter Certification. Call 484-796-4041 to register or for more information.


