Sealed proposals will be received at the Township Administrative Office, 1025 Paoli Pike, West Chester, PA. until 10:00 a.m. on November 8, 2019. Bid opening will be at 10:15 a.m., November 8, 2019, at the West Goshen Township Municipal Complex.

1.02 Preparation of Proposal

Proposal must be submitted on the form provided in these specifications. Proposal must be submitted in a sealed envelope bearing on the outside the name of the bidder and his address, and shall be clearly marked:

“PROPOSAL FOR THE SALE OF SURPLUS VEHICLES:

If forwarded by mail, the sealed envelope containing the proposal and marked as designated above, must be enclosed in another envelope addressed as indicated in paragraph 1.01.

1.03 Bid Security

This bid must be accompanied by a Certified Check, Bank Draft or Cashier Check in the amount equal to ten (10%) percent of the total bid made payable to **West Goshen Township**. Cash is not acceptable and shall not be submitted.

1.04 Awarding

The award will be made at the Public Session of the Board of Supervisors meeting on November 19, 2019, or at a meeting so designated by the Board. The Township reserves the right to reject any and/or all proposals, and to waive technicalities as may be deemed best in the Township's interest. Award will be based on the highest bid submitted. Highest bidder will be notified by mail and shall be required to make full payment to the Township in the full amount of the bid and remove the vehicle within ten (10) days of written notice. Payment may be made by a Certified Check, Bank Draft, or Cashier Check, payable to **West Goshen Township**; or Cash. Cash will only be accepted between the hours of 9:00 a.m. and 2:00 p.m.
