RESOLUTION NO. 0-2021

RESOLUTION OF THE BOARD OF SUPERVISORS OF WEST GOSHEN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, SETTING THE COMPENSATION OF THE WEST GOSHEN TOWNSHIP TAX COLLECTOR FOR THE TERM OF ELECTIVE OFFICE COMMENCING ON THE FIRST MONDAY OF JANUARY, 2022, FOR THE COLLECTION AND DEPOSIT OF REAL ESTATE TAXES LEVIED BY THE BOARD OF SUPERVISORS OF WEST GOSHEN TOWNSHIP AND OFFICIAL APPOINTMENT OF THE TAX COLLECTOR.

BE IT AND THE SAME IS HEREBY RESOLVED, by the Board of Supervisors of West Goshen Township that the compensation of the West Goshen Township Tax Collector for the term of elective office commencing on the first Monday of January, 2022, for the collection and deposit of real estate taxes levied by West Goshen Township shall be as follows:

1. The Tax Collector's compensation for the collection of regular real estate taxes, full-year interim real estate taxes and part-year interim real estate taxes shall be in the sum of \$_____ per annum, but in no event shall exceed five (5%) percent of the amount of the taxes so collected. Payments to the Tax Collector on account of the amounts collected by him shall be made in bi-weekly installments of \$_____ each, commencing with the first pay date in 2022 for the Township Administrative Staff. Thereafter, in subsequent years, during the term of the Tax Collector, his compensation shall be similarly paid.

2. The Tax Collector's actual and needful expenditures for printing, postage, record books, blanks, and forms shall be reimbursed by West Goshen Township as

authorized by Section 35 of the Act of May 25, 1945, P.L. 1050, as amended, 72 P.S. §5511.35.

3. The West Goshen Township Tax Collector shall deposit tax receipts on a daily basis directly to the designated West Goshen Township bank account and shall furnish a deposit receipt to the Township, together with account cards or copies of paid tax bills or other itemized accounting of each such deposit; provided, however, receipts may be accumulated to no more than a total of One Thousand (\$1,000.00) Dollars before a deposit is required.
